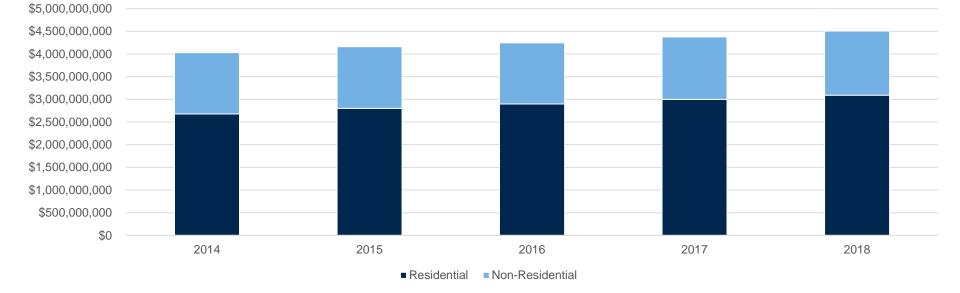

### Key Points of Debt Management Plan

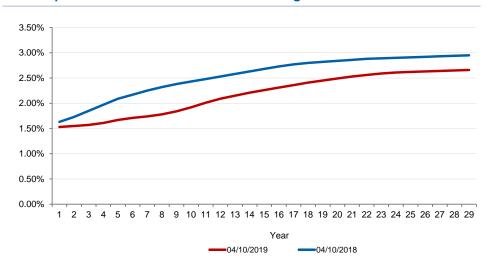
- To meet current capital needs, voters approved the issuance of \$15,000,000 in general obligation bonds on February 3, 2015 to be sold over a period of four years.
  - \$8,800,000 sold in 2015.
  - \$6,200,000 sold in 2018.
  - Sale of bonds (\$15 million) was structured to maintain tax rate of 0.75 mils down from 1.00 historically.
    - No tax rate increase required.
    - Voters approved increasing operational mil levy from 1.00 to 1.25 mils for operations, maintenance and capital improvements.
  - 13-year final maturity (20-year maximum).
  - The Branch College has no additional voter authorized bonds
- Future bond election in 2019 for \$16,000,000.
  - No tax rate increase will be required.
  - FMP process will determine size of election
  - Elections can be held every four years.



### Long-Term Market

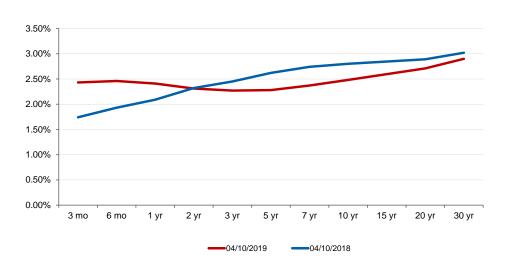
#### Market Overview

Fixed income assets traded in a narrow range for most of the week before selling off on Friday. Benign readings on inflation and continued uncertainty on the trade/tariff front supported Treasuries and municipals last week, but strong bank earnings, favorable economic statistics out of China, and a big merger in the energy sector created a risk-on environment at the end of the week. Municipals continued to benefit from a moderate new issue calendar and continued heavy municipal bond fund inflows and outperformed Treasuries across the maturity spectrum. By the end of the week, US Treasuries were seven basis points higher in the five and ten year ranges and eight basis points higher in the thirty year range. The Municipal Market Data AAA yield closed the week two basis points higher in the two year range, three basis points higher in the five year range, unchanged in ten years and two basis points lower in the thirty year range. Municipal/Treasury yield ratios closed the week two percentage points above of the prior week's levels in the ten year range and over three percentage points higher in the thirty year range.



#### Municipal GO "AAA" MMD Yield Curve Changes



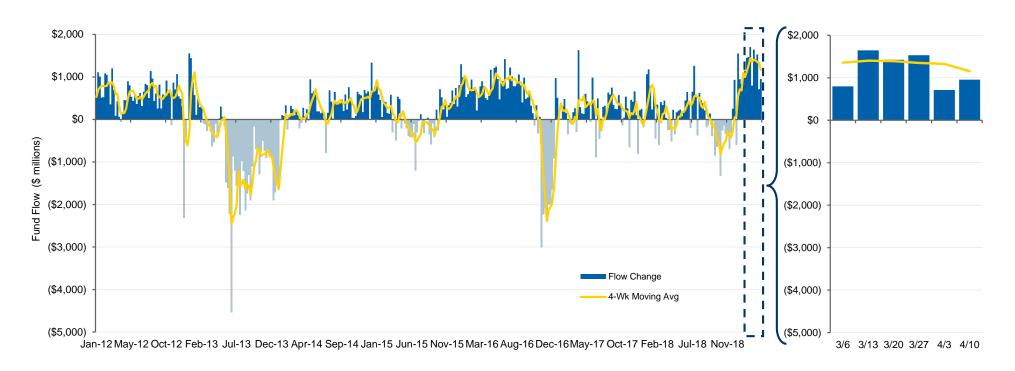


### Municipal Market Fund Flows

According to data from Lipper, for the week ended April 10, 2019, weekly municipal bond funds reported \$956.451 million of inflows, after the previous week's \$713.606 million of inflows

- Long-term muni bond funds experienced inflows, gaining \$906.806 million in the latest week, after inflows of \$430.846 million in the previous week
- Four week moving average is currently positive at \$1.157 billion, down from last week's number of \$1.329 billion

#### Shift in "AAA" MMD Since April 2018



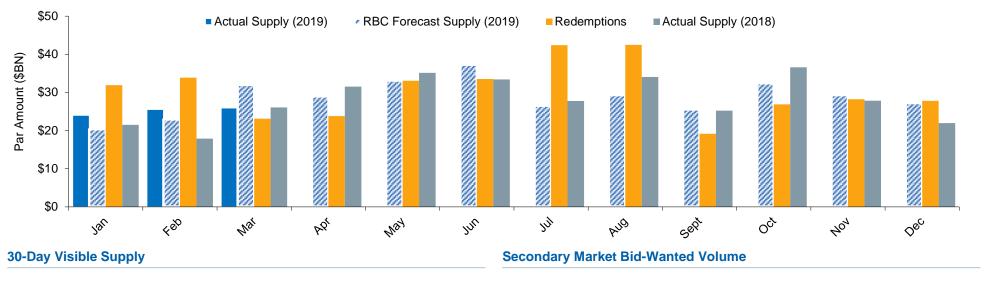

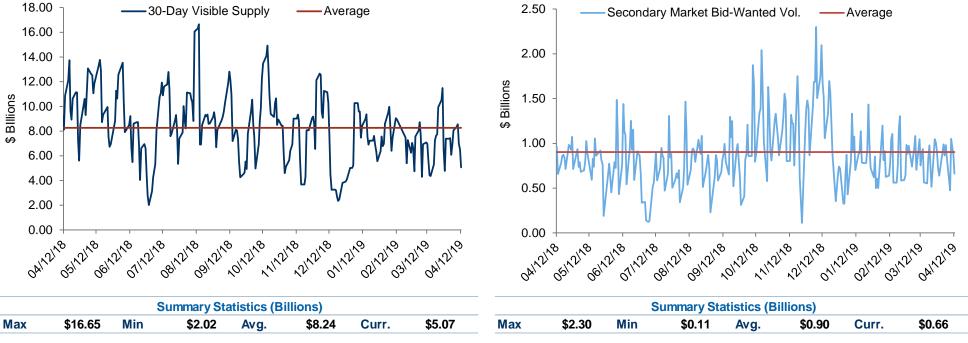

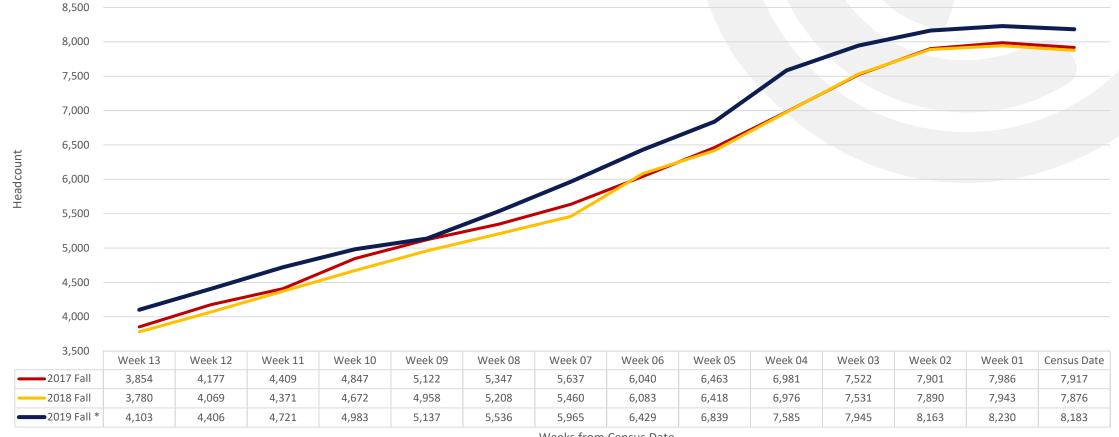

DACC Headcount Comparison

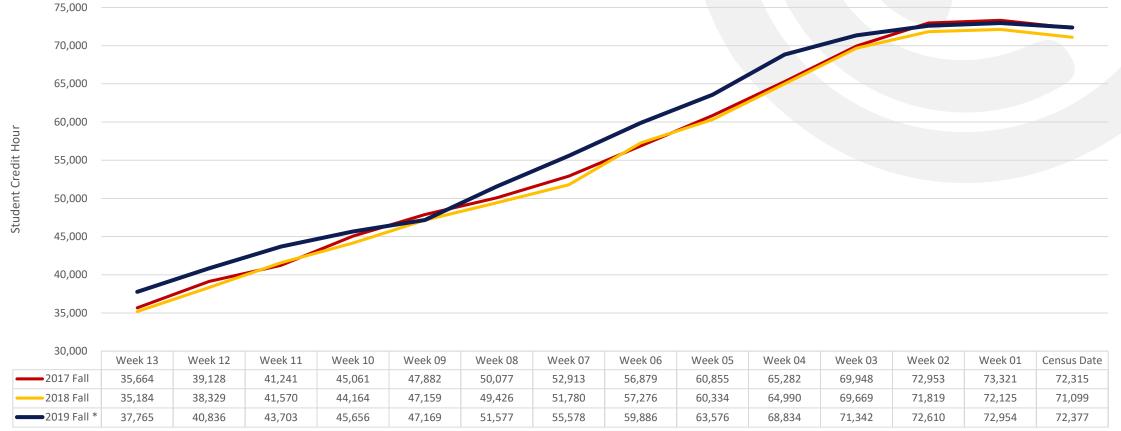

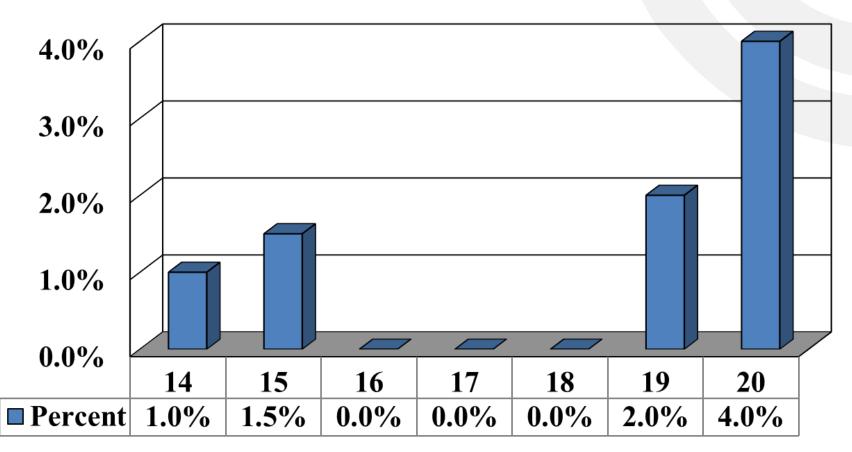






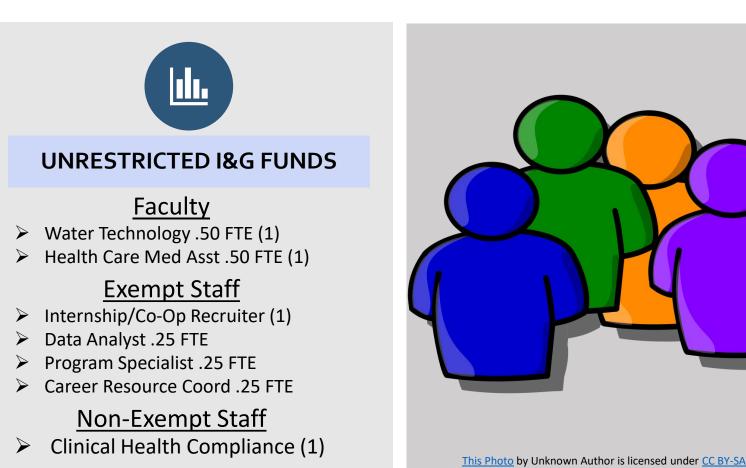
### **SALARY CHANGES**

## **DACC Capital Strategy**

- DACC's capital strategy is based on a "cycling" financing approach that uses a combination of local General Obligation (GO) bond funding and assumptions about potential state funding support.
- Each cycle is four years long. Local GO bond debt is managed to maintain a consistent tax rate. Statewide GO bonds are issued every two years (even years).
   State allocations are competitive and generally encourage a local match of anywhere from 25% to 75%.
- The development of a Facilities Master Plan identifies capital needs for the next eight years, or for two GO bond cycles, and revisits and validates anticipated capital needs prior to the second GO bond election.
- This bond election covers GO bond Cycle 6 which will address capital needs from 2019 to 2022. Based on an analysis by DACC's Financial Advisor (RBC Capital Markets), the college plans to ask voters to approve \$16 million in GO bonds in 2019 (Cycle 6).

## 1. East Mesa Campus, Las Cruces, NM – Site and physical improvements HED Approval 4/13/16 BOF 5/17/2016

#### Current Status: Nearly Complete Cost: \$2,000,000

The East Mesa Campus is now DACC's primary campus. The East Mesa Campus will maintain a presence of all academic programs. Its major focus will be business and information systems, technical studies programs with synergy with business and information systems, and general studies. The development strategy will be to continue to provide additional classrooms, laboratories, faculty offices and associated academic support to meet expected enrollments in all phases of development. The immediate capital improvement focus will be site development activities to relocate overhead electric lines, provide a new entrance road from Sonoma Ranch Boulevard, and provide an expanded facility for physical plant activities. The next phase of development will continue to provide additional classrooms, laboratories, and support space for expected student enrollments.

#### 2. Central Campus at NMSU – Space renovation and facility renewal HED Approval 11/13/18 BOF 12/15/2015 Current Status: Completed

#### Cost: 2,500,000

The Central Campus at NMSU will continue to maintain a presence of all academic programs. Its major focus will be on technical studies, and health and public services. Adult basic education will continue at the site. As the original DACC campus, this site has the oldest facilities. The immediate capital improvement focus is to renovate the original 1978 building to upgrade the classroom and laboratory facilities to optimal designed configurations and improve information technology capabilities.

## 3. Workforce Development Ctr, Las Cruces, NM - Lab expansion and facility renewal Will be submitted to HED Current Status: In Progress – Bond Sale 2018

#### Cost: 1,500,000

The Workforce Center will continue to focus on workforce development and customized training. It will also serve as a supplementary site for technical studies (i.e., apprenticeship, facilities maintenance and/or construction-related industries) and adult basic education classroom space. The immediate capital improvement focus will be to provide an addition to support the electronics program, and provide roof and parking lot repairs.

## 4. Gadsden Center – Phase 3 for additional classrooms, labs, support space - To be resubmitted to HED Current Status: In Progress – Bond Sale 2015/2018 Cost: 5,000,000

The immediate focus will be to expand the Gadsden Center with additional classrooms and laboratories to accommodate expected enrollments and support its role as the hub for academic and financial services to the southern and border areas. The new expansion project would accommodate an approximate 18,000 square feet building, site development, and additional parking. The building program needs to consider space for classrooms, laboratories, and faculty offices; it should also consider a library, student success, and lecture space.

## 5. Infrastructure improvements/facility renewal satellites – Small projects under 300k threshold Current Status: Ongoing

#### Cost: 2,000,000

For our other facilities, roof systems, heating, ventilating and air conditioning systems, building lighting and power systems, building interior finishes and exterior envelopes in need of major repair and replacement.

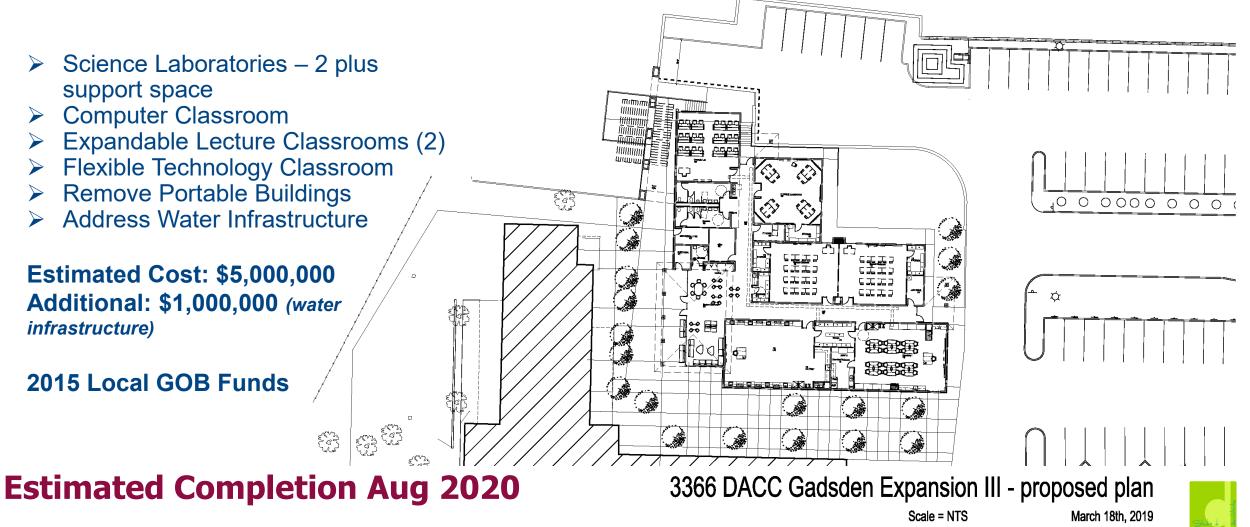
## 6. Technology/equipment acquisition – small projects under 300k threshold Current Status: Ongoing Cost: 2,000,000

For all campuses, upgrade of information technology, network, wireless access, fiber optic lines and server replacements. We plan to issue a separate series of bonds with short maturity (one or two years) for equipment purchases which will insure that items such as computer hardware and software maintain a useful like equal to or exceeding the maturity of the Bonds.

- DACC has undertaken a project to complete a comprehensive review of safety and security concerns at all campus. - Examples of some of the items already identified include exterior and interior lighting needs, electrical hazards, sidewalk repairs, grounds work to address access and safety issues, signage, ADA door repairs and replacements, alarm system replacements, improvements to bio hazard, maintenance, and IT storage spaces, fencing repairs and replacements, etc. (Access Control & Surveillance in IT Master Plan)

## **PROPOSED BOND PROJECTS - 5**

Information Technology/Upgrades/Equipment Acquisition – all campuses LCL GOB \$4,000,000 – Proposed State Match \$2,000,000 – Total \$6,000,000

- As part of the master planning process and included in the 2019-2026 DACC master plan, DACC commissioned an IT Master plan conducted by Bridgers & Paxton to identify IT infrastructure needs in order to address network and wireless connectivity and technology at each campus.
- A detailed list of IT needs was developed that breaks down information into the following four primary categories:
  - Infrastructure includes upgrades to cabling, wifi, VoIP, UPS, etc.
  - IT Spaces includes removal of old abandoned cabling, moving outside IT spaces indoors, and proper set up of cable and IT data racks.
  - Security & Surveillance Systems includes access control and security systems.
  - Audio Visual Systems includes updating and upgrades to IT equipment and addition of technology in support of DACC Apple initiative.



Gadsden Advanced Technology Center – Gadsden Campus LCL GOB \$3,000,000 – Proposed State Match \$2,500,000 – Total \$5,500,000

- 15,800 square feet for construction of an Advanced Technology Building at the DACC Gadsden Campus. Serves Chaparral, Sunland Park, and Anthony.
- This project is planned to provide 2 technology labs and 2 classrooms in addition to storage and office space.
- This would support the implementation of Integrated Technologies training to include the following program areas:
  - Cyber Security (identified as a State Priority Sector; DACC already working with GISD on planned career pathway)
  - Embedded Technology Programming (HVAC, aerospace, fridges, security, etc.
  - Enterprise Programming (Amazon, Oracle)
  - Mobile Device Programming (phones, devices, remotes, etc.)
  - Web Programming
- Supports entire southern area of DAC to include Anthony, Chaparral, and Sunland Park
