Call to Order: Ms. Elva Garay, President, called the DACC Advisory Board meeting to order at

## 1. Looking Ahead - Dr. Mónica Torres

**Key Discussion Points:** Dr. Torres welcomed everyone to the meeting. She noted all of the different things

> that have taken place since seeing the Board at the last meeting in May. Theme of this meeting will be the "state of the college." Dr. Torres items such as the value proposition for education, the positive impacts education has on individuals and communities all in relation to DACC's strategic direction – ensure citizens of Doña Ana County with access and benefit from the opportunities available at DACC.

### 2. System Integration – Dr. Dan Arvizu, NMSU Chancellor

**Key Discussion Points:** NMSU Chancellor, Dr. Dan Arvizu presented to the board information on the systems

> administrative realignment - branch campus restructuring. Each campus has unique traits tailored to the communities they serve. The decision to move quickly on the restructuring was precipitated by serious budget crunches, namely a system level significant cut to I&G funding which mostly pays for salaries. The community colleges are in better shape than NMSU Main – \$11M cut for NMSU before fully

accounting for revenue losses not yet recognized; ~\$1M for DACC; and ~\$2M from the other 3 community colleges combined. Chancellor is meeting with each of the communities impacted. Restructuring of governance approach for 3 smaller campuses, will leave DACC as is for now. Declining enrollment for the entire system was reviewed. Chancellor will investigate what, if anything, needs to be done with DACC administrative structure. "Swirling" (students who are co-enrolled between different campuses in the system) has been stopped. Students declared as NMSU majors are not allowed to take courses at any of the community colleges. Swirling accounts for an ~\$7.5M loss in revenue for NMSU per year. The swirling situation also has federal financial aid implications. DACC spends a lot of money providing classes for the Early College High Schools and dual credit and don't receive much, if any revenue/compensation for these courses. Goal is to engage in communities in ways that meet their needs better than we have before. Mission of community college is not to change. Chancellor wants community colleges to look into working with Arrowhead Park. Make sure we are advocating in the communities, to make more of an impact at lower operational expenses, and to do things differently and more impactful. IPEDS data was reviewed regarding I&G Total cost per student FTE; I&G Salary cost per student FTE and per degree/certificate granted – DACC does a lot more with less. But should DACC offer more certificates due to changing environment. Integrated system means to integrate synergy for all involved in the system.

#### 3. COVID-19 Updates and Prevention Planning – Amy Collins & Becky Corran

**Key Discussion Points:** 

Amy Collins, DACC Contact Tracer & Becky Corran, Public Health Professor provided an update regarding COVID-19 as it relates to DACC. COVID-19 impacts to DACC specifically, health disparities, our student population (many essential workers) were discussed. Not just impacts on our state, but our students that come from El Paso and the surrounding border area. This is all considered when determining how to deliver our services best. Spread rate is again on an upward trend. Reviewed DACC COVID Response Framework which is based on the NMSU Ready Plan, NMHED, DOH, CDC guidelines. DACC emergency decision-making values were highlighted. Minimize contact, control spread — everything that can be offered remotely will be. Prior to coming onto campus, everyone must do building check-in and self-assessment process. Goal is to minimize and mitigate spread of the virus. Working to provide materials in both English and Spanish. DACC is ensuring social distancing and limiting the density of individuals in approved lab/hybrid classes; building check-in procedures for all coming to campus; follow-up by identifying high risk individuals to reduce risk of spread, and contact tracing.

### 5. Business & Finance - Ms. Kelly Brooks

**Key Discussion Points:** 

K. Brooks updated the group on the 2020-21 budget situation. Pandemic and falling oil and gas revenues mean significant budget cuts. Discussed projected revenue impacts; significant impact from declining enrollment; and projected expenditure impacts. College-wide budget reductions, departments are to provide targeted reductions at both 5% and 10% to cover approximately \$800K. Plan for current and future potential impacts. Following DACC budget principles: positions and initiatives that drive student success; opportunities that promise new sources of revenue; eliminate operations duplication where possible; seek budgetary solutions; prioritize keeping existing personnel where possible (80% of budget is salary and fringes); and alignment with DACC's strategic plan. Statewide GO Bond projects will be on the November ballot – creative campus information provided, including draft framework; collaborative effort to building state-of-the-art center of digital media complex. Will benefit all district public school students. Hoping to do bond sale in February 2021 and possible refunding.
