Frequently asked questions about repeats, exercising the Adjusted Credit Option (ACO), etc., and how they affect the Dental Hygiene application.

- 1) **A student earns a "D" or an "F" in a prerequisite and repeats the courses. How is the new grade treated in the application?** The new grade replaces the D/F or the best grade is considered. The D/F is not averaged into the GPA. Two attempts maximum are allowed.
- 2) **A student repeats a prerequisite in which a "C" grade is earned. How is the new grade treated in the application process?** The new grade replaces the C or the best grade is considered. The C is not averaged into the GPA. Two attempts maximum are allowed.
- 3) **Is there a cap on the number of times a student can repeat a course before the student will no longer be considered?** Yes, two attempts maximum are allowed. However, students admitted to the program are not allowed to repeat any of the courses within the Dental Hygiene Program. If a student fails to meet minimum requirements, the student will be dismissed from the program and will need to re-apply.
- 4) **Is there an expiration time on prerequisites or other courses in this program?** Yes, 5 years is the standard time for all science courses.
- 5) **How is transfer work treated in my application to the program?** Grades from other college(s) are calculated together with grades earned at DACC/NMSU.
- 6) **Is the prerequisite GPA looked at alone or is it a combination of the prerequisites and the cumulative GPA?** Both are looked at, points are given for prerequisite GPA and points are given for science GPA.
- 7) **How does exercising the Adjusted Credit Option (ACO) affect the application?** Some selective admission programs add or deduct points for exercising the ACO. This program does not. Students and advisors should, however, be aware of the overall consequences of exercising the ACO. The policy is outlined under the Academic Regulations section of the current DACC catalog.
- 8) **Felony/Misdemeanor Information** Check with the program to learn what restrictions apply. Convictions may prevent a student from partaking in extracurricular rotations, and/or obtaining their license after graduation.
